Discount:	Amount:	Eligibility and Submission Requirements:
Sibling	15%	<ul style="list-style-type: none"> Sibling discounts are not reflected on the oldest child but are given to each additional child in our program.
LCA Alumni	10%	<ul style="list-style-type: none"> If a parent or legal guardian is an alumni of Life Center Academy, your children are eligible for this discount. Include your year of graduation along with the other requirements in the body of your email.
FLC Membership*	20%	<ul style="list-style-type: none"> If you are an active, giving and serving member in our church community that has completed our Growth Track program, your children are eligible for this discount. Include the name of where you serve in our church community (Greeter, Host, Student Ministries, Worship Team...etc.). Our team will contact the serve team coordinators to confirm your membership.
Minister *	10%	<ul style="list-style-type: none"> If you are an employed minister, serving in a local church, your child may be eligible for this discount. Include the name of the church where you serve as a minister and include your ministry license or credentialing paperwork in the email.
Military *	10%	<ul style="list-style-type: none"> If you are active or honorably discharged veteran, your children may be eligible for this discount. Include a copy of your most recent LES or your DD-214 for confirmation.
First Responder*	10%	<ul style="list-style-type: none"> If you are employed as law enforcement or a first responder (Fire or EMS), you may be eligible for this discount. Include a letter from your company on a company letterhead, stating your name and job title. Alternatively, you can submit a most recent copy of your pay stub, <i>as long as the pay stub states your place of employment.</i>

*Indicates discounts that must be resubmitted each year to receive your discount.
